Many thanks for your prompt reply. I fully understand the various considerations mentioned – responses vary between publishers (and disciplines).

The JALCA articles for which Dr Antunes has submitted manuscripts are:

There is also a JSLTC manuscript, but I don't have any information on JSLTC policies and will need to make a similar enquiry.

The first step in checking for repository permissions is usually the Sherpa RoMEO tool (<http://www.sherpa.ac.uk/romeo/>), which is a directory of publisher policies. JALCA and JSLTC are listed in RoMEO, but their policies are not known. You can see the JALCA entry at <http://www.sherpa.ac.uk/romeo/issn/0002-9726/>.

As I mentioned, we won't make any manuscript available on our system until we are certain we have permission, but when an item is made live, it will be fully publicly available - we can't, for example, limit access to university staff or students. These are of course factors a publisher must take into account, and often the solution is a compromise where authors are permitted to deposit only their submitted or accepted manuscripts, sometimes with an embargo period. In other cases we may not be able to use any version, and sometimes permission is required on a per-item basis.

Hi. I manage the research repository at The University of Northampton, and we've had several JALCA articles submitted by one of our academics, Dr. Paula Antunes. In addition to the bibliographic details, Paula has uploaded a number of full texts. We don't make these available until we've checked the copyright situation and journal policies.

I've been unable to find any reuse policies listed online for JALCA and was hoping you could provide details. Is there scope for JALCA authors to deposit their work in university repositories, and if so which versions are permitted (published version, final draft etc.)?

To clarify what deposit to our repository means:

1. The uploaded file will be publicly available for download, without login requirements or other restrictions
2. It will be made available for harvesting by other services such as Google Scholar
3. A coversheet will be added to the file noting the original publication source and details, along with any required links or notices

Any advice you can offer would be greatly appreciated.
